#### 5. REPORT FROM THE EMERGENCY MANAGER

- 45 Day Financial and Operation Plan (FOP) was submitted on Friday, June 1<sup>st</sup> and placed on the website today. The FOP may be located at http://www.mhpsnet.org/EFM\_Reports.html.
- Mr. Schiller noted there was a meeting with the State Treasurer's Office, Michigan
  Department of Education (MDE), John Lewis, Alena Zachery-Ross, Tracey French, the
  MHPSA Board and himself for updates regarding the operation of the Muskegon Heights
  Public Schools Academy.
- Mr. Schiller also noted in an ongoing conversation to have the Elected and the PSA Boards meet, Jim Goenner has asked that the meeting not be held until after the conclusion of professional development with the PSA Board.
- MLK, Jr. Elementary doors and windows have been boarded. MHPS has received a
  purchase agreement from one perspective buyer who has made two non-refundable down
  payments. The closing is scheduled in mid-August.
- Auction for materials left in MLK, Jr. Elementary should be in the next two to three weeks.
- A meeting is scheduled this week with John Severson, Superintendent for MAISD, to
  address the Technology Millage. Senator Hansen has proposed legislations to include the
  only two districts in Michigan that have chartered their entire District (Muskegon Heights and
  Highland Park). If the legislation passes the PSA will collect monies from the millage.
- Muskegon Heights Public School Academy commencement is Thursday, June 4<sup>th</sup> at 7:00 pm.
