# 6. REPORT FROM THE ASSISTANT SUPERINTENDENT

# **Cash Flow**

Made the two Emergency Loan payments plus the QZAB transfer was made last month. Cash remains positive for the coming year. Area of concern that impacts our budget is the declining enrollment at the Academy. We receive 3% of state therefore as enrollment declines so does our funds. We were receiving appropriate \$15,000 every month in authorizer's fees we are now receiving \$13,500. The number of students enrolled at the academy may be found on various on various websites (MI School Data, Michigan Website and State Aid Status Reports). Cash will remain positive even with that adjustment. Not as bad as losing tax base but it is still an adjustment.

# Revenue - Expenditure - Fund Balance

We received operating taxes from our summer levies which are a little lagging. Spoke to the City of Muskegon Heights they hired a new person so disbursements should be on a more timely manner.

# **Long Term Liabilities**

Decrease due to increase because of the restructure of the Emergency Loans in the amount of \$203,000 other than that everything remains constant.
