THE EMERGENCY MANAGER, GREGORY WEATHERSPOON,  
HEREBY ISSUES THE FOLLOWING:

**ORDER TO AMEND AGREEMENT FOR CONTINUED PROVISION OF SERVICES  
BETWEEN THE SCHOOL BOARD FOR THE DISTRICT OF THE CITY OF  
MUSKEGON HEIGHTS, AMEND THE CHARTER CONTRACT BETWEEN THE  
SCHOOL DISTRICT OF THE CITY OF MUSKEGON HEIGHTS BOARD OF  
EDUCATION AND THE MUSKEGON HEIGHTS PUBLIC SCHOOL ACADEMY  
SYSTEM; AND TO APPROVE THE DISBURSEMENT AGREEMENT BETWEEN THE  
SCHOOL BOARD FOR THE SCHOOL DISTRICT OF THE CITY OF MUSKEGON  
HEIGHTS AND THE MUSKEGON HEIGHTS PUBLIC SCHOOL ACADEMY SYSTEM**

By the authority of the Local Financial Stability and Choice Act granted under Public Act 436 of the Public Acts of Michigan, 2012, (the "Act"), and the appointment of the Emergency Manager for the District by the Governor of the State of Michigan pursuant to that Act, the following preamble and order is issued:

WHEREAS:

1. Pursuant to Section 12 (g)(j) of the Act, the Emergency Manager intends to amend the Agreement for Continued Provision of Services previously entered into between the District and Muskegon Heights Public School Academy System, for the continued provision of services under the Agreement.

2. Pursuant to Section 12 (g)(j) of the Act, the Emergency Manager intends to amend the Charter Contract entered into between the District and the Muskegon Heights Public School Academy System on July 9, 2012, to allow for the First Amendment and Second Amendment of the Management Agreements and to further provide for orderly transition to a new educational services provider and to issue a request for proposal of services for the 2014/2015 school year.

3. Pursuant to Section 12 (c)(d) of the Act, the Emergency Manager intends to enter into an agreement whereby funds for continued operation of the Public School Academy shall be distributed to the PSA together with conditions for any disbursement.

NOW, THEREFORE, BE IT ORDERED THAT:


1. The District through its Emergency Manager enter into and execute on behalf of the District the Amended and Restated Agreement for Continued Provision of Services between the District and the Public School Academy System.

2. The Emergency Manager enter into and execute the Contract Amendment No. 1 between the District as the authorizing body and the Muskegon Heights Public School Academy System.

3. The Emergency Manager enter into and execute the Disbursement Agreement between the District and the Muskegon Public School Academy System.

4. All three documents described herein be attached to this Order and be incorporated into this Order by reference thereto.
